To see if the District will vote to authorize the Clerk-Treasurer, with the approval of the Prudential Committee, to enter into Compensating Balance Agreements, as permitted by Massachusetts General laws, Chapter 44, Section 53F, for the fiscal year beginning July 1, 2013 and ending on June 30, 2014, or act anything thereon or thereunto.

To see if the District will vote to authorize the Clerk-Treasurer, with the approval of the Prudential Committee, to borrow in anticipation of revenue for the fiscal year beginning July 1, 2013 and ending June 30, 2014, in accordance with the Massachusetts General laws, Chapter 44, section 4 and the Acts in amendment thereof, and including in addition thereto, Chapter 849 of the Acts of 1969, as amended, and to renew any note or notes as may be given for a period of less than one year in accordance with the Massachusetts General Laws, Chapter 44, section 17 or act anything thereon or thereunto.

ARTICLE: 10

To see if the District will vote to adopt the provisions of M.G.L. Chapter 32B, Section 20 to establish an account entitled "Other Post-Employment Benefits Liability Trust Fund" or OPEB Trust Fund as defined in Governmental Accounting Standards Board, Statements 43 and 45 for the purpose of funding future financial obligations of the District for health insurance benefits of retirees. The District Treasurer shall be the custodian of the OPEB Trust fund.

This article initiates the ability to set up a future funding source for the new GASB directives mandating funding of retirees health benefits. The Auditors and Department of Revenue Division of Local Services recommend providing funding. This also reflects well on our financial statements and will be favorably viewed affecting future borrowing rates, bond ratings and audit reporting.

To see if the District will vote to amend Article VI, Section 2 of the Onset Fire District By-Laws as follows:

(1) by deleting the fifth sentence of the first paragraph of Section 2 and replacing the deleted sentence with the following:

The Board of Engineers shall have full and absolute authority in the administration and operation of the Fire Department and its personnel who shall obey their orders.

(2) by deleting the sixth sentence of the first paragraph of Section 2 and replacing the deleted sentence with the following:

The Board of Engineers shall purchase, subject to the approval of the Prudential Committee, and keep in good repair all property used by and for the Fire Department.

(3) by deleting the seventh sentence of the first paragraph of Section 2 and replacing the deleted sentence with the following:

The Board of Engineers shall be responsible for the general superintendence and control

of all fire apparatus and all other property of the Fire Department.
