I appreciate that the MassGOP, in response to a flurry of negative mail from Sarah Hewins' party, stepped in to support my campaign, but I would have approached the facts with a different tone. The mail my campaign has sent has been positive and focused on the issues and my accomplishments for my constituents.

Yesterday, I received the mailer at my home. After having some time to review it, I must say I find it to be factual while perhaps a bit over the top. It was, after all, not sent by me or approved by me.

I reviewed the facts, and Sarah's responses. She lies repeatedly in her responses. As far as I can conclude the mailer is entirely factual.

## To demonstrate:
